

September 2019 HSBC Credit Cards Standard Promotion Terms & Conditions

1. The September 2019 HSBC Credit Cards Standard Promotion (hereinafter referred to as “**CCSP1909HS-Promotion**”) is organized by Compargo Malaysia Sdn Bhd (1050769-U) for CompareHero.my and in partnership with HSBC Bank Malaysia Berhad (127776-V) and HSBC Amanah Malaysia Berhad (807705-X), (hereinafter collectively referred as “**HSBC**”), as a Service Provider for bank products that are being applied for.
2. HSBC credit cards eligible for CCSP1909HS-Promotion are HSBC Amanah MPower Visa Platinum Credit Card-i, HSBC Visa Platinum and HSBC Visa Signature (hereinafter referred to as “**Eligible Credit Cards**”).

Promotion Period

3. The CCSP1909HS-Promotion comprises of the following periods:
 - a. “**Sign-Up Period**” runs from 23 September 2019 to 31 October 2019, both dates inclusive; and
 - b. “**Spend Period**” defined as 60 days from the date of the HSBC credit card welcome letter; and
 - c. “**Redemption Period**” runs from 15 October 2019 to 28 February 2020, both dates inclusive.

Promotion Eligibility

4. The CCSP1909HS-Promotion is open to individuals who are:
 - a. 21 years old and above, with a valid MyKad and residential address in Peninsular Malaysia; and
 - b. successfully registers interest for any of the Eligible Credit Cards via CompareHero.my website (<https://www.comparehero.my>) or Facebook (www.facebook.com/CompareHero.my) or Instagram (www.instagram.com/comparehero.my) during the Sign-Up Period; and
 - c. have their application of the Eligible Credit Cards approved and activated (hereinafter referred to as “**Cardholder/s**”) within forty-five (45) days from the end date of CCSP1909HS-Promotion.
5. The following individuals are not eligible for the CCSP1909HS-Promotion:
 - a. those who have registered under a different CompareHero.my promotion within three (3) months from the start date of CCSP1909HS-Promotion; and/or
 - b. HSBC cardholders who cancel any of the Eligible Credit Cards within three (3) months from the date of approval of their Eligible Credit Cards’ application; and/or
 - c. existing HSBC cardholders who are participating in any other concurrent HSBC credit card promotions; and/or
 - d. holder(s) of invalid or cancelled HSBC Eligible Credit Cards and/or whose accounts are delinquent within HSBC’s definition at any time during the Sign-Up Period; and/or
 - e. holder(s) of a company and/or corporate HSBC credit cards; and/or
 - f. those who make a direct or online application for any of Eligible Credit Cards at any HSBC branch / HSBC websites / HSBC sales representatives / other third-party sales agents.
6. CompareHero.my reserves the right to reject information submitted on the CompareHero.my website and social media if we deem it not legible, in non-English alphabets, use of foul language, or suspected as spam.

Promotion Mechanics

7. Cardholders who perform a “**Minimum Spend**” of RM1,000.00 (or equivalent in foreign currency) on “**Eligible Spend**” in a single or cumulative receipt(s) within the Spend Period will be considered a “**Successful Cardholder**”.
 - a. **Eligible Spend** of the CCSP1909HS-Promotion are spend charged to the Eligible Credit Cards, subject to the conditions below:
 - i. includes: internet transactions, local and overseas retail transactions, standing instructions/auto-billing, Cash Advance, Balance Transfer and Cash Instalment Plan;
 - ii. excludes: finance charges/management fees and credit card annual fees for the Eligible Credit Cards.
8. Each Successful Cardholder is entitled to only one (1) CCSP1909HS-Promotion gift (hereinafter referred to as “**Promotion Gift**”), regardless of number of approved and activated Eligible Credit Cards from HSBC.
9. Promotion Gift is defined as three (3) units of Xiaomi Mi Home Security Camera 360°.

Gift Redemption

10. For the avoidance of doubt, it is the Successful Cardholder's responsibility to redeem the Promotion Gift within the Redemption Period.
11. CompareHero.my will contact all Successful Cardholders to redeem the Promotion Gift, between 4-8 weeks after card activation (pending official HSBC reports):
 - a. via email (email address in CompareHero.my's record) with gift redemption instructions; and/or
 - b. via SMS (mobile phone number in CompareHero.my's record) as a reminder to respond to the email above.
12. At the time of gift redemption, should a Successful Cardholder be unable to provide a residential address in Peninsular Malaysia or declines the said Promotion Gift, a "**Substitute Gift**" will be issued.
 - a. Substitute Gift is defined as a RM200 Lazada eVoucher and request for other options will not be entertained.
13. Promotion Gift or Substitute Gift cannot be transferred to other parties, is not refundable and not exchangeable for cash, credit, or other goods.
14. Promotion Gift or Substitute Gift is considered redeemed when a Successful Cardholder responds to the gift redemption email instructions before the end of the Redemption Period.
