



### January 2019 Flash Deal Terms & Conditions

- The (“**January 2019 Flash Deal**”) is organized by Compargo Malaysia Sdn Bhd (1050769-U) for CompareHero.my (“**The Organiser**”).
- The **January 2019 Flash Deal** shall run from 00:00, 16 January 2019 to 23:59, 18 January 2019, with both dates and times (Malaysian Standard Time) inclusive (“**January 2019 Flash Deal Period**”).
  - **The Organizer** reserves the right to end earlier or extend the **January 2019 Flash Deal Period**.
- Depending on context, the following shall be collectively known as (“**Participating Bank**”) and (“**Eligible Credit Cards**”) for the **January 2019 Flash Deal**:
  - Citibank
    - Citi Simplicity+ Card
    - Citi Clear Card
    - Shell-Citi Card
    - Citi Cash Back Card
    - Citi Cash Back Platinum Card
    - Citi Rewards Visa Signature
    - Citi PremierMiles Visa Card
- The **January 2019 Flash Deal** is open to individuals:
  - 21 years old and above, residing in Malaysia; and
  - successfully registers interest for any of the **Eligible Credit Cards** issued by **Participating Bank** via CompareHero.my website (www.comparehero.my) or social media advertisements during the **January 2019 Flash Deal Period**.
- The following individuals are not eligible for the **January 2019 Flash Deal**:
  - those that hold active **Eligible Credit Cards** issued by the **Participating Banks** in the last 6 (six) months prior to the **January 2019 Flash Deal** start date; or
  - those that cancelled any of the **Eligible Credit Cards** issued by the **Participating Bank** within 6 (six) months prior to the **January 2019 Flash Deal** start date; or

- **The Organiser** reserves the right to approve or reject information submitted at the CompareHero.my website or lead forms without assigning any reason.
- Depending on context, the following shall be collectively known as (“**Flash Deal Gift**”) for in the **January 2019 Flash Deal**:
  - SHARP 40" Full HD LED TV-LC40SA5100M - limited to a maximum quantity of 150 (one hundred & fifty) units only.
