

This Amended Terms and Conditions for April 2019 HSBC Credit Cards Standard Promotion will supersede the existing Terms and Conditions with effect from 1 May 2019. This Promotion is extended until 14 May 2019 and clause 3(a) has been amended to reflect the extended Sign-Up Period.

April 2019 HSBC Credit Cards Standard Promotion Terms & Conditions

1. The April 2019 HSBC Credit Cards Standard Promotion (hereinafter referred to as “**CCSP1904HS-Promotion**”) is organized by Compargo Malaysia Sdn Bhd (1050769-U) for CompareHero.my and in partnership with HSBC Bank Malaysia Berhad (127776-V) and HSBC Amanah Malaysia Berhad (807705-X), collectively known as “HSBC”.
2. HSBC credit cards eligible for CCSP1904HS-Promotion are HSBC Amanah MPower Visa Platinum Credit Card-i, HSBC Visa Platinum and HSBC Visa Signature (hereinafter referred to as “**Eligible Credit Cards**”).

Promotion Period

3. The CCSP1904HS-Promotion comprises of the following periods:
 - a. “**Sign-Up Period**” runs from 19 April 2019 to ~~30 April 2019~~ 14 May 2019, both dates inclusive; and
 - b. “**Spend Period**” defined as 60 days from the date of the HSBC credit card welcome letter; and
 - c. “**Redemption Period**” runs from 15 May 2019 to 31 October 2019, both dates inclusive.

Promotion Eligibility

4. The CCSP1904HS-Promotion is open to individuals who are:
 - a. 21 years old and above, with a valid MyKad and residing in Peninsular Malaysia; and
 - b. successfully registers interest for any of the Eligible Credit Cards via CompareHero.my website (<https://www.comparehero.my>) or Facebook (www.facebook.com/CompareHero.my) or Instagram (www.instagram.com/comparehero.my) during the Sign-Up Period; and
 - c. have their application of the Eligible Credit Cards approved and activated (hereinafter referred to as “**Cardholder/s**”) within forty-five (45) days from the end date of CCSP1904HS-Promotion.
5. The following individuals are not eligible for the CCSP1904HS-Promotion:
 - a. those who have registered under a different CompareHero.my promotion within three (3) months from the start date of CCSP1904HS-Promotion; and/or
 - b. HSBC cardholders who cancel any of the Eligible Credit Cards within three (3) months from the date of approval of their Eligible Credit Cards’ application; and/or
 - c. existing HSBC cardholders who are participating in any other concurrent HSBC credit card promotions; and/or
 - d. holder(s) of invalid or cancelled HSBC Eligible Credit Cards and/or whose accounts are delinquent within HSBC’s definition at any time during the Sign-Up Period; and/or
 - e. holder(s) of a company and/or corporate HSBC credit cards; and/or
 - f. those who make a direct or online application for any of Eligible Credit Cards at any HSBC branch / HSBC websites / HSBC sales representatives / other third-party sales agents.
6. CompareHero.my reserves the right to reject information submitted on the CompareHero.my website and social media if we deem it not legible, in non-English alphabets, use of foul language, or suspected as spam.

Promotion Mechanics

7. Cardholders who perform a “**Minimum Spend**” of RM1,000.00 (or equivalent in foreign currency) on “**Eligible Spend**” in a single or cumulative receipt(s) within the Spend Period will be considered a “**Successful Cardholder**”.
 - a. **Eligible Spend** of the CCSP1904HS-Promotion are spend charged to the Eligible Credit Cards, subject to the conditions below:
 - i. includes: internet transactions, local and overseas retail transactions, standing instructions/auto-billing, Cash Advance, Balance Transfer and Cash Instalment Plan;
 - ii. excludes: finance charges/management fees and credit card annual fees for the Eligible Credit Cards.
8. Each **Successful Cardholder** is entitled to only one (1) “**CCSP1904HS-Promotion Gift**”, regardless of number of approved and activated Eligible Credit Cards from HSBC.

- a. **CCSP1904HS-Promotion Gift** is defined as one (1) unit of Elba Air Fryer, model number EAF-G3014⁺ (hereinafter referred to as “**Promotion Gift**”)
 - i. ⁺ Successful Cardholders residing in East Malaysia will receive a RM200 Lazada eVoucher instead.

Gift Redemption

10. CompareHero.my will provide an online gift redemption form to request the delivery address from the Successful Cardholder for the fulfilment and delivery of the Promotion Gift.
11. Successful Cardholders are responsible for providing their correct delivery information before the end of the Redemption Period. Any attempt of gift redemption after the Redemption Period will not be entertained and no gift will be given.
12. The Lazada eVoucher will be delivered in the form of a unique code via email to the respective Successful Cardholder. The Cardholders can key-in the unique code in the "Promo Code" box on Lazada's website prior to completing his/her transaction in order to redeem the eVoucher.
13. CompareHero.my and HSBC is not in any way endorsing, sanctioning, approving or supporting the use of Lazada or any brand or merchandise sold thereon. Any query and/or dispute on the usage of the eVouchers must be directed to, and resolved directly with Lazada.
14. The validity of the eVouchers is for a period of six (6) months from the date of receiving the unique code from HSBC Bank/HSBC Amanah.
15. Promotion Gift is estimated to be fulfilled between 6-8 weeks from the activation date of the approved Eligible Credit Cards (pending official bank reports, stock availability, and delivery schedules).
16. Promotion Gift choice of colour is at the discretion of CompareHero.my and based on available stock.
17. CompareHero.my can replace the Promotion Gift with something of equivalent or higher value if it runs out of stock.
18. CompareHero.my is not responsible for any loss, damage, delay, tampering, theft or modification of the Promotion Gift once it has been collected from CompareHero.my's place of dispatch for delivery by the courier company.
19. All servicing or warranty claims should be directed to the manufacturer or distributor of the Promotion Gift. Please refer to warranty card / box / notification attached with the Promotion Gift.

CompareHero.my reserves the right as it deems fit to vary or change any of these terms and conditions from time to time or cancel, terminate, withdraw, or suspend this Promotion and/or replace this Promotion with another similar promotion, Promotion or program with prior notice.
