



Standard Chartered April 2019 Hero Giveaway Campaign Terms & Conditions

Terms and Conditions (Effective from 9th April 2019)

1. The Standard Chartered April 2019 Hero Giveaway Campaign (hereinafter referred to as "**Campaign**") is organized by Compargo Malaysia Sdn Bhd (1050769-U) for **CompareHero.my** and in partnership with Standard Chartered Bank Malaysia Berhad (115793-P) ("**Standard Chartered**")

Campaign Period

2. The **Campaign** comprises of a "**Sign-Up Period**" that runs from 00:00 9 April 2019 to 23:59 11 April 2019, both times and dates inclusive.

Campaign Eligibility

3. The **Campaign** is open to individuals who are:
 - a. Malaysian residents, 21 years old and above; and
 - b. successfully registers interest for any of the **Eligible Credit Cards** via CompareHero.my website (<https://www.comparehero.my>) or Comparehero.my social media pages, including Facebook (www.facebook.com/CompareHero.my) and Instagram (www.instagram.com/comparehero.my) during the **Sign-Up Period**; and
 - i. "**Eligible Credit Cards**" are Standard Chartered JustOne Platinum Mastercard®, Standard Chartered Visa Platinum and Standard Chartered WorldMiles World Mastercard®.
 - c. is either a New-to-Bank or New-to-Card applicant.
 - i. New-to-Bank is defined as a person who does not have any accounts or a financial relationship with a bank.
 - ii. New-to-Card is defined as existing bank customer who does not hold any active credit card/s from a bank.
4. The following individuals are not eligible for the **Campaign**:
 - a. those who have registered under a different or previous **CompareHero.my** campaign within the last six (6) months prior to the start date of this **Campaign**; and/or
 - b. those who cancel any of the **Eligible Credit Cards** within the last six (6) months prior to the start date of this **Campaign**; and/or
 - c. those who had unsuccessful/unapproved applications of the **Eligible Credit Cards** within three (3) months prior to the start date of this **Campaign**; and/or
 - d. those who make a direct or online application for any of **Eligible Credit Cards** at any of the **Participating Banks** branch / own website / direct sales representative / other third-party sales agents.
5. **CompareHero.my** reserves the right to reject information submitted at the CompareHero.my website or social media if we deem it not legible, in non-English alphabets, use of foul language, suspected as spam.

Campaign Mechanics

 - a. (“**Successful Cardholder**”) is defined as:
