

May 2019 48-Hour Hero Giveaway Promotion Terms & Conditions

1. The May 2019 Hero Giveaway Promotion (hereinafter referred to as “**CCHG190548-Promotion**”) is organized by CompareHero Malaysia Sdn Bhd (1050769-U) for CompareHero.my.
2. The following shall be collectively known as “**Participating Banks**” and “**Eligible Credit Cards**” of the CCHG190548-Promotion:
 - a. Standard Chartered Bank Malaysia Berhad: Standard Chartered Liverpool FC Cashback, Standard Chartered WorldMiles World Mastercard®, Standard Chartered Visa Platinum Card and Standard Chartered JustOne Platinum Mastercard®.

Promotion Period

3. The CCHG190548 -Promotion comprises of the following periods:
 - a. “**Sign-Up Period**” runs from 28 May 2019 to 29 May 2019, both dates inclusive; and
 - b. “**Qualifying Period**” runs for forty-five (45) days from 28 May 2019 to 12 July 2019, both dates inclusive; and
 - c. “**Redemption Period**” runs from 15 June 2019 to 30 November 2019, both dates inclusive.

Promotion Eligibility

4. The CCHG190548-Promotion is open to individuals who are:
 - a. 21 years old and above, residing in Peninsular Malaysia; and
 - b. successfully registers interest for any of the Eligible Credit Cards via CompareHero.my website (<https://www.comparehero.my>) or Facebook (<www.facebook.com/CompareHero.my>) or Instagram (<www.instagram.com/comparehero.my>) during the Sign-Up Period; and
 - c. is either a New-to-Bank or New-to-Card applicant; and
 - i. New-to-Bank is defined as a person who does not have any accounts or a financial relationship with a bank.
 - ii. New-to-Card is defined as existing bank customer who does not hold any active credit card/s from a bank
 - d. have their application of the Eligible Credit Cards from the Participating Banks approved and activated (hereinafter referred to as “**Cardholder/s**”) within the Qualifying Period.
5. The following individuals are not eligible for the CCHG190548-Promotion:
 - a. those who have registered under a different CompareHero.my promotion within three (3) months from the start date of CCHG190548-Promotion; and/or
 - b. existing Participating Banks cardholders who cancel any of the Eligible Credit Cards within three (3) months from the date of approval of their Eligible Credit Cards’ application; and/or
 - c. existing Participating Banks cardholders who are participating in any other concurrent Participating Banks credit card promotions; and/or
 - d. holder(s) of invalid or cancelled Participating Banks Eligible Credit Cards and/or whose accounts are delinquent within the Participating Banks definition at any time during the Sign-Up Period; and/or
 - e. holder(s) of a company and/or corporate Participating Banks credit cards; and/or
 - f. those who make a direct or online application for any of Eligible Credit Cards at any Participating Banks branch / Participating Banks websites / Participating Banks sales representatives / other third-party sales agents.
6. CompareHero.my reserves the right to reject information submitted on the CompareHero.my website and social media if we deem it not legible, in non-English alphabets, use of foul language, or suspected as spam.

Promotion Mechanics

7. Cardholders who fulfil Promotion Eligibility (clauses 4 and 5) will be considered a “**Successful Cardholder**” of the CCHG190548-Promotion.
8. Each **Successful Cardholder** is entitled to only one (1) “**CCHG190548-Promotion Gift**”, regardless of number of approved and activated Eligible Credit Cards from Participating Banks.
 - a. **CCHG190548-Promotion Gift** is defined as one (1) unit of JBL Charge 3⁺ (hereinafter referred to as “**Promotion Gift**”)

12. The Lazada eVoucher will be delivered in the form of a unique code via email to the respective Successful Cardholder. The Cardholders can key-in the unique code in the “Promo Code” box on Lazada’s website prior to completing his/her transaction in order to redeem the eVoucher.
