

May 2019 Citibank Credit Cards Flash Deal Promotion Terms & Conditions

1. The May 2019 Citibank Credit Cards Flash Deal Promotion (hereinafter referred to as “**CCFD1905CT-Promotion**”) is organized by Compargo Malaysia Sdn Bhd (1050769-U) for CompareHero.my and in partnership with Citibank Berhad (297089-M) (hereinafter referred to as “**Citibank**” or “**Citi**”).
2. Citibank credit cards eligible for CCFD1905CT-Promotion are Citi Simplicity+ Card , Citi Rewards Visa Signature, Shell-Citi Credit Card, Citi PremierMiles Visa Card, Citi Clear Card, Citi Cash Back Platinum Card and Citi Cash Back Card (hereinafter referred to as “**Eligible Credit Cards**”).

Promotion Period

3. The CCFD1905CT -Promotion comprises of the following periods:
 - a. “**Sign-Up Period**” runs from 13 May 2019 to 15 May 2019, both dates inclusive; and
 - b. “**Qualifying Period**” defined as 60 days from card approval date; and
 - c. “**Redemption Period**” runs from 15 June 2019 to 30 September 2019, both dates inclusive.

Promotion Eligibility

4. The CCFD1905CT-Promotion is open to individuals who are:
 - a. 21 years old and above, residing in Peninsular Malaysia; and
 - b. successfully registers interest for any of the Eligible Credit Cards via CompareHero.my website (<https://www.comparehero.my>) or Facebook (www.facebook.com/CompareHero.my) or Instagram (www.instagram.com/comparehero.my) during the Sign-Up Period; and
 - c. is either a New-to-Bank or New-to-Card applicant; and
 - i. New-to-Bank is defined as a person who does not have any accounts or a financial relationship with Citibank.
 - ii. New-to-Card is defined as existing bank customer who does not hold any active credit card/s from Citibank.
 - d. have their application of the Eligible Credit Cards approved and activated (hereinafter referred to as “**Cardholder/s**”) within forty-five (45) days from the end date of CCFD1905CT-Promotion.
5. The following individuals are not eligible for the CCFD1905CT-Promotion:
 - a. those who have registered under a different CompareHero.my promotion within three (3) months from the start date of CCFD1905CT-Promotion; and/or
 - b. existing Citibank cardholders who cancel any of the Eligible Credit Cards within six (6) months from the date of approval of their Eligible Credit Cards’ application; and/or
 - c. existing Citibank cardholders who are participating in any other concurrent Citibank credit card promotions; and/or
 - d. holder(s) of invalid or cancelled Citibank Eligible Credit Cards and/or whose accounts are delinquent within Citibank’s definition at any time during the Sign-Up Period; and/or
 - e. holder(s) of a company and/or corporate Citibank credit cards; and/or
 - f. any person who has committed or suspected of committing any misconduct, fraudulent or wrongful acts in relation to their card account/s, any facility, service or accommodation granted by Citibank, including Citibank Online (website); and/or
 - g. those who make a direct or online application for any of Eligible Credit Cards at any Citibank branch / Citibank websites / Citibank sales representatives / other third-party sales agents.
6. CompareHero.my reserves the right to reject information submitted on the CompareHero.my website and social media if we deem it not legible, in non-English alphabets, use of foul language, or suspected as spam.

Promotion Mechanics

7. Cardholders who fulfil Promotion Eligibility (clauses 4 and 5) and perform a minimum three (3) times “Eligible Spend” (of any amount) within the Qualifying Period will be considered as **“Shortlisted Cardholders”**.
 - a. **Eligible Spend** of the CCFD1905CT-Promotion means the purchase of any goods or services (local or international) with the use of the same Eligible Credit Card and may, at Citibank discretion, include any card transaction as may be determined by Citibank except for the following transactions:
 - i. instalments paid under Citibank’s FlexiPayment Plan, EPP transactions, Credit Shield Plus, Quick Cash, Balance Transfer, Balance Transfer via Instalment Plan and Cash Advance; and/or
 - ii. any disputed, cancelled, refunded, unauthorized or fraudulent purchase transactions; and/or
 - iii. payment of annual Citi Credit Card membership fees; and/or
 - iv. interest payments, late payment fees, charges for cash withdrawals, Goods and Service; and/or
 - v. tax or other taxes and any other form of service/miscellaneous fees; and/or
 - vi. finance charges/management fees and credit card annual fees for the Eligible Credit Cards.
8. At the end of the Qualifying Period, Shortlisted Cardholders will be sorted by the earliest to the latest date the third (3rd) Eligible Spend was met and the date and time of the registration of interest via CompareHero.my during the Sign-Up Period.
9. The first one hundred and twenty five (125) of the sorted Shortlisted Cardholders will then become **“Successful Cardholder/s”** of the CCFD1905CT-Promotion and be honoured with one (1) **“CCSW1904HS-Promotion Gift”** each.
 - a. **CCFD1905CT-Promotion Gift** is defined as one (1) pair of Apple AirPods 2 + (hereinafter referred to as **“Promotion Gift”**), and limited to one hundred and twenty five (125) pairs only.
 - i. + Successful Cardholders residing in East Malaysia will receive a RM200 Lazada eVoucher instead.
10. Each Successful Cardholder is entitled to only one (1) Promotion Gift, regardless of number of approved and activated Eligible Credit Cards from Citibank.

Gift Redemption

11. Promotion Gift cannot be transferred to other party or parties, and is not exchangeable for cash, credit, or other goods.
12. CompareHero.my will provide an online gift redemption form to request the delivery address from the Successful Cardholder for the fulfilment and delivery of the Promotion Gift.
13. Successful Cardholders are responsible for providing their correct delivery information before the end of the Redemption Period. Any attempt of gift redemption after the Redemption Period will not be entertained and no gift will be given.
14. The Lazada eVoucher will be delivered in the form of a unique code via email to the respective Successful Cardholder. The Cardholders can key-in the unique code in the “Promo Code” box on Lazada’s website prior to completing his/her transaction in order to redeem the eVoucher.
15. CompareHero.my and Citibank is not in any way endorsing, sanctioning, approving or supporting the use of Lazada or any brand or merchandise sold thereon. Any query and/or dispute on the usage of the eVouchers must be directed to, and resolved directly with Lazada.
16. The validity of the eVouchers is for a period of six (6) months from the date of receiving the unique code from CompareHero.my.
17. Promotion Gift is estimated to be fulfilled between 6-8 weeks from the activation date of the approved Eligible Credit Cards (pending official bank reports, stock availability, and delivery schedules).
18. Promotion Gift choice of colour is at the discretion of CompareHero.my and based on available stock.
19. CompareHero.my can replace the Promotion Gift with something of equivalent or higher value if it runs out of stock.
20. CompareHero.my is not responsible for any loss, damage, delay, tampering, theft or modification of the Promotion Gift once it has been collected from CompareHero.my’s place of dispatch for delivery by the courier company.
21. All servicing or warranty claims should be directed to the manufacturer or distributor of the Promotion Gift. Please refer to warranty card / box / notification attached with the Promotion Gift.
