

August 2019 Standard Chartered Credit Cards Standard Promotion Terms & Conditions

1. The August 2019 Standard Chartered Credit Cards Standard Promotion (hereinafter referred to as “**CCSP1908SC-Promotion**”) is organized by Compargo Malaysia Sdn Bhd (1050769-U) for CompareHero.my and in partnership with Standard Chartered Bank Malaysia Berhad (115793-P) (hereinafter referred to as “**Standard Chartered**”).
2. Standard Chartered credit cards eligible for CCSP1908SC-Promotion are Standard Chartered WorldMiles World Mastercard®, Standard Chartered Visa Platinum Card and Standard Chartered JustOne Platinum Mastercard® (hereinafter referred to as “**Eligible Credit Cards**”).

Promotion Period

3. The CCSP1908SC -Promotion comprises of the following periods:
 - a. “**Sign-Up Period**” runs from 1 August 2019 to 23 September 2019, both dates inclusive; and
 - b. “**Redemption Period**” runs from 15 September 2019 to 31 January 2020, both dates inclusive.

Promotion Eligibility

4. The CCSP1908SC-Promotion is open to individuals who are:
 - a. 21 years old and above, with a residential address in Peninsular Malaysia; and
 - b. successfully registers interest for any of the Eligible Credit Cards via CompareHero.my website (<https://www.comparehero.my>) or Facebook (www.facebook.com/CompareHero.my) or Instagram (www.instagram.com/comparehero.my) during the Sign-Up Period; and
 - c. is either a New-to-Bank or New-to-Card applicant; and
 - i. New-to-Bank is defined as a person who does not have any accounts or a financial relationship with Standard Chartered.
 - ii. New-to-Card is defined as existing bank customer who does not hold any active credit card/s from Standard Chartered.
 - d. have their application of the Eligible Credit Cards approved and activated (hereinafter referred to as “**Cardholder/s**”) within forty-five (45) days from the end date of CCSP1908SC-Promotion.
5. The following individuals are not eligible for the CCSP1908SC-Promotion:
 - a. those who have registered under a different CompareHero.my promotion within three (3) months from the start date of CCSP1908SC-Promotion; and/or
 - b. existing Standard Chartered cardholders who cancel any of the Eligible Credit Cards within three (3) months from the date of approval of their Eligible Credit Cards’ application; and/or
 - c. existing Standard Chartered cardholders who are participating in any other concurrent Standard Chartered credit card promotions; and/or
 - d. holder(s) of invalid or cancelled Standard Chartered Eligible Credit Cards and/or whose accounts are delinquent within Standard Chartered’s definition at any time during the Sign-Up Period; and/or
 - e. holder(s) of a company and/or corporate Standard Chartered credit cards; and/or
 - f. those who make a direct or online application for any of Eligible Credit Cards at any Standard Chartered branch / Standard Chartered websites / Standard Chartered sales representatives / other third-party sales agents.
6. CompareHero.my reserves the right to reject information submitted on the CompareHero.my website and social media if we deem it not legible, in non-English alphabets, use of foul language, or suspected as spam.

Promotion Mechanics

7. Cardholders who fulfil Promotion Eligibility (clauses 4 and 5, and its subclauses) will be considered a “**Successful Cardholder**” of the CCSP1908SC-Promotion.
8. Each Successful Cardholder is entitled to only one (1) CCSP1908SC-Promotion gift (hereinafter referred to as “**Promotion Gift**”), regardless of number of approved and activated Eligible Credit Cards from Standard Chartered.
9. Promotion Gift is defined as a Khind Small Appliance Set that consists of:
 - a. One (1) Khind Air Fryer (Model ARF26), and
 - b. One (1) Khind Food Chopper (Model FPC808).

Gift Redemption

10. For the avoidance of doubt, at the time of gift redemption, should a Successful Cardholder be unable to provide a residential address in Peninsular Malaysia or declines the said Promotion Gift, a “**Substitute Gift**” will be issued.
 - a. Substitute Gift is defined as a RM200 Lazada eVoucher and request for other options will not be entertained.

12. CompareHero.my will contact all Successful Cardholders between 4-8 weeks after card activation date (pending official Standard Chartered reports):
 - a. via email (email address in CompareHero.my’s record) with gift redemption instructions; and/or
 - b. via SMS (mobile phone number in CompareHero.my’s record) as a reminder to respond to the email above.
13. Promotion Gift or Substitute Gift is considered redeemed when a Successful Cardholder responds to the gift redemption email instructions before the end of the Redemption Period. Any attempt of gift redemption after the Redemption Period will not be entertained and no Promotion Gift will be issued.
14. Delivery or fulfilment of Promotion Gift is estimated to be between 2-4 weeks from redeemed date (pending stock availability, and/or merchant delivery schedules).
15. Promotion Gift or Substitute Gift choice of size, technical specifications and/or colour is at the discretion of CompareHero.my, based on available stock from the merchant/s. CompareHero.my can replace the Promotion Gift or Substitute Gift with something of equivalent or higher value if the merchant/s runs out of stock.
