

This amended Terms and Conditions for HSBC Personal Financing-i Promotions will supersede the existing Terms and Conditions with effect from 1 August 2019. The Promotion Period has been extended and clause 2 has been amended to reflect the changes.

HSBC Personal Financing-i Promotion Terms & Conditions

1.
