

October 2019 Citibank Credit Cards Flash Deal 2 Promotion Terms & Conditions

1. The October 2019 Citibank Credit Cards Flash Deal 2 Promotion (hereinafter referred to as “CCFD1910CT2-Promotion”) is organized by Compargo Malaysia Sdn Bhd (1050769-U) for CompareHero.my and in partnership with Citibank Berhad (297089-M) (hereinafter referred to as “Citibank” or “Citi”) as a Service Provider for bank products that are being applied for.
2. Citibank credit cards eligible for CCFD1910CT2-Promotion are Citi Simplicity+ Card, Citi Rewards Visa Signature, Citi PremierMiles Visa Card, Citi Clear Card, Citi Cash Back Platinum Card and Citi Cash Back Card (hereinafter referred to as “Eligible Credit Cards”).

Promotion Period

3. The CCFD1910CT2-Promotion comprises of the following periods:
 - a. “Sign-Up Period” runs from 21 October 2019 to 23 October 2019, both dates inclusive; and
 - b. “Redemption Period” runs from 15 November 2019 to 28 February 2020, both dates inclusive.

Promotion Eligibility

4. The CCFD1910CT2-Promotion is open to individuals who are:
 - a. 21 years old and above, with a residential address in Peninsular Malaysia; and
 - b. is either a New-to-Bank or New-to-Card applicant; and
 - i. New-to-Bank is defined as a person who does not have any accounts or a financial relationship with Citibank.
 - ii. New-to-Card is defined as existing bank customer who does not hold any active credit card/s from Citibank.
 - c. must register interest, during the Sign-Up Period, for any of the Eligible Credit Cards on CompareHero.my website, to get redirected to Citibank website; and
 - d. completes the Citibank online application process before the end of the Sign-Up Period; and
 - e. have their application of the Eligible Credit Cards approved and activated (hereinafter referred to as “Cardholder/s”).
5. The following individuals are not eligible for the CCFD1910CT2-Promotion:
 - a. permanent and/or contract employees of Citibank (including its subsidiaries and related companies) and their respective immediate family members; and/or
 - b. representatives and/or agents (including advertising and campaign agents) of Citibank and their respective immediate family members; and/or
 - c. any individuals who had cancelled any of his/her Citibank credit card within six (6) months before the date of application and is re-applying for any Citibank Credit Card under the CCFD1910CT2-Promotion; and/or
 - d. present holders of any Citibank credit card(s) whether issued in Malaysia or otherwise; and/or
 - e. any person who has committed or suspected of committing any misconduct, fraudulent or wrongful acts in relation to their card account(s), any facility, service or accommodation granted by Citibank, including Citibank Online (Website); and/or
 - f. those who apply for any of Eligible Credit Cards via other methods from Clause 4(c) and 4(d).
6. CompareHero.my reserves the right to reject information submitted on the CompareHero.my website and social media if we deem it not legible, in non-English alphabets, use of foul language, or suspected as spam.

Promotion Mechanics

7. Cardholders who fulfil Promotion Eligibility (clauses 4 and 5, and its subclauses) will be sorted according to:
 - a. the Eligible Credit Card activation date (closest to Sign-Up Period to furthest from Sign-Up Period); and
 - b. registration of interest date and time of the Eligible Credit Card via CompareHero.my during the Sign-Up Period.
8. The first sixty (60) Cardholders on the sorted list will be considered “Successful Cardholders” of the CCFD1910CT2-Promotion.
9. Each Successful Cardholder is entitled to only one (1) CCFD1910CT2-Promotion gift (hereinafter referred to as “Promotion Gift”), regardless of number of approved and activated Eligible Credit Cards from Citibank.
10. **Promotion Gift** is defined as one (1) unit of Nintendo Switch Lite) - limited to a maximum quantity of sixty (60) units only.

11. Successful Cardholders who receive the Promotion Gift are not able to participate in other sign-up card campaigns, promotions or offers by Citibank or its third-party sales agents.

Gift Redemption

12. For the avoidance of doubt, it is the Successful Cardholder's responsibility to redeem the Promotion Gift within the Redemption Period.
13. CompareHero.my will contact all Successful Cardholders to redeem the Promotion Gift, between 4-8 weeks after card activation (pending official Citibank reports):
 - a. via email (email address in CompareHero.my's record) with gift redemption instructions; and/or
 - b. via SMS (mobile phone number in CompareHero.my's record) as a reminder to respond to the email above.
14. At the time of gift redemption, should a Successful Cardholder be unable to provide a residential address in Peninsular Malaysia or declines the said Promotion Gift, a "**Substitute Gift**" will be issued.
 - a. Substitute Gift is defined as a RM200 Lazada eVoucher and request for other options will not be entertained.
15. Promotion Gift or Substitute Gift cannot be transferred to other parties, is not refundable and not exchangeable for cash, credit, or other goods.
16. Promotion Gift or Substitute Gift is considered redeemed when a Successful Cardholder responds to the gift redemption email instructions before the end of the Redemption Period. Any attempt of gift redemption after the Redemption Period will not be entertained and no Promotion Gift will be issued.
17. Delivery or fulfilment of Promotion Gift is estimated to be between 2-4 weeks from redeemed date (pending stock availability, and/or merchant delivery schedules).
18. Promotion Gift or Substitute Gift choice of size, technical specifications and/or colour is at the discretion of CompareHero.my, based on available stock from the merchant/s. CompareHero.my can replace the Promotion Gift or Substitute Gift with something of equivalent or higher value if the merchant/s runs out of stock.
19. Promotion Gift or Substitute Gift does not include any accessories or items (unless stated) that may be shown on any marketing materials, as they are for illustration purposes only.
20. The use of the Promotion Gift is subject to terms and conditions of the issuing merchant/s. All additional terms and conditions will be stated in full, upon delivery or fulfilment of Promotion Gift. Additional terms and conditions may include validity dates, spend requirements, applicable or exclusion products and other conditions. The issuing merchant/s reserves the right to alter, cancel, terminate or suspend the order or any part thereof or any part of the applicable terms and conditions from time to time, with or without any prior notice.
