



This Amended Terms and Conditions for August 2019 Standard Chartered Credit Cards Standard Promotion will supersede the existing Terms and Conditions with effect from 16 October 2019. The Promotion Gift has been changed and clause 9 has been amended to reflect the changes.

September 2019 Standard Chartered Credit Cards Standard Promotion Terms & Conditions

- The September 2019 Standard Chartered Credit Cards Standard Promotion (hereinafter referred to as "CCSP1909SC-Promotion") is organized by Compargo Malaysia Sdn Bhd (1050769-U) for CompareHero.my and in partnership with Standard Chartered Bank Malaysia Berhad (115793-P), (hereinafter referred to as "Standard Chartered"), as a Service Provider for bank products that are being applied for.
- Standard Chartered credit cards eligible for CCSP1909SC-Promotion are Standard Chartered WorldMiles World
 Mastercard®, Standard Chartered Visa Platinum Card and Standard Chartered JustOne Platinum Mastercard®
 (hereinafter referred to as "Eligible Credit Cards").

Promotion Period

- 3. The CCSP1909SC -Promotion comprises of the following periods:
 - a. "Sign-Up Period" runs from 23 September 2019 to 31 October 2019, both dates inclusive; and
 - p. "Redemption Period" runs from 15 October 2019 to 31 January 2020, both dates inclusive.

Promotion Eligibility

- 4. The CCSP1909SC-Promotion is open to individuals who are:
 - a. 21 years old and above, with a residential address in Peninsular Malaysia; and
 - b. is either a New-to-Bank or New-to-Card applicant; and
 - New-to-Bank is defined as a person who does not have any accounts or a financial relationship with Standard Chartered.
 - ii. New-to-Card is defined as existing bank customer who does not hold any active credit card/s from Standard Chartered.
 - c. successfully <u>registers interest</u> for any of the Eligible Credit Cards via CompareHero.my website (https://www.comparehero.my) or Facebook (www.facebook.com/CompareHero.my) or Instagram (www.instagram.com/comparehero.my) during the Sign-Up Period; and
 - d. have their application of the Eligible Credit Cards <u>approved and activated</u> (hereinafter referred to as "Cardholder/s") within forty-five (45) days from the end date of CCSP1909SC-Promotion.
- 5. The following individuals are <u>not eligible</u> for the CCSP1909SC-Promotion:
 - a. those who have registered under a different CompareHero.my promotion within three (3) months from the start date of CCSP1909SC-Promotion; and/or
 - b. existing Standard Chartered cardholders who cancel any of the Eligible Credit Cards within six (6) months from the date of approval of their Eligible Credit Cards' application; and/or
 - c. existing Standard Chartered cardholders who are participating in any other concurrent Standard Chartered credit card promotions; and/or
 - d. holder(s) of invalid or cancelled Standard Chartered Eligible Credit Cards and/or whose accounts are delinquent within Standard Chartered's definition at any time during the Sign-Up Period; and/or
 - e. holder(s) of a company and/or corporate Standard Chartered credit cards; and/or
 - f. those who make a direct or online application for any of Eligible Credit Cards at any Standard Chartered branch / Standard Chartered websites / Standard Chartered sales representatives / other third-party sales agents.
- 6. CompareHero.my reserves the right to reject information submitted on the CompareHero.my website and social media if we deem it not legible, in non-English alphabets, use of foul language, or suspected as spam.

Promotion Mechanics

- 7. Cardholders who fulfil Promotion Eligibility (clauses 4 and 5, and its subclauses) will be considered a "Successful Cardholder" of the CCSP1909SC-Promotion.
- 8. Each Successful Cardholder is entitled to only one (1) CCSP1909SC-Promotion gift (hereinafter referred to as "Promotion Gift"), regardless of the number of approved and activated Eligible Credit Cards from Standard Chartered.
- 9. Promotion Gift is defined as a single unit of <u>Tefal Fry Delight Hot Air Fryer (TEF-FX1000)</u>.





Gift Redemption

- 10. For the avoidance of doubt, it is the Successful Cardholder's responsibility to redeem the Promotion Gift within the Redemption Period.
- 11. CompareHero.my will contact all Successful Cardholders to redeem the Promotion Gift, between 4-8 weeks after card activation (pending official Standard Chartered reports):
 - a. via email (email address in CompareHero.my's record) with gift redemption instructions; and/or
 - b. <u>via SMS</u> (mobile phone number in CompareHero.my's record) as a reminder to respond to the email above.
- 12. At the time of gift redemption, should a Successful Cardholder be unable to provide a residential address in Peninsular Malaysia or declines the said Promotion Gift, a "**Substitute Gift**" will be issued.
 - a. Substitute Gift is defined as a RM200 Lazada eVoucher and request for other options will not be entertained.
- 13. Promotion Gift or Substitute Gift cannot be transferred to other parties, is not refundable and not exchangeable for cash, credit, or other goods.
- 14. Promotion Gift or Substitute Gift is considered <u>redeemed</u> when a Successful Cardholder responds to the gift redemption email instructions <u>before the end of the Redemption Period</u>. Any attempt of gift redemption after the Redemption Period will not be entertained and no Promotion Gift will be issued.
- 15. Delivery or fulfilment of Promotion Gift is estimated to be between 2-4 weeks from redeemed date (pending stock availability, and/or merchant delivery schedules).
- 16. Promotion Gift or Substitute Gift choice of size, technical specifications and/or colour is at the discretion of CompareHero.my, based on available stock from the merchant/s. CompareHero.my can replace the Promotion Gift or Substitute Gift with something of equivalent or higher value if the merchant/s runs out of stock.
- 17. Promotion Gift or Substitute Gift does not include any accessories or items (unless stated) that may be shown on any marketing materials, as they are for illustration purposes only.
- 18. The use of the Promotion Gift is subject to terms and conditions of the issuing merchant/s. All additional terms and conditions will be stated in full, upon delivery or fulfilment of Promotion Gift. Additional terms and conditions may include validity dates, spend requirements, applicable or exclusion products and other conditions. The issuing merchant/s reserves the right to alter, cancel, terminate or suspend the order or any part thereof or any part of the applicable terms and conditions from time to time, with or without any prior notice.
- 19. All servicing or warranty claims should be directed to the merchant, manufacturer or distributor of the Promotion Gift or Substitute Gift. Please refer to warranty card / box / notification attached with the Promotion Gift.
