

February 2020 Standard Chartered Credit Cards Hero Giveaway Promotion Terms & Conditions

1. This Standard Chartered Credit Cards Hero Giveaway Promotion (hereinafter referred to as “**CCHG2002SC-Promotion**”) is organized by Compargo Malaysia Sdn Bhd (1050769-U) for CompareHero.my and in partnership with Standard Chartered Bank Malaysia Berhad (115793-P) (hereinafter referred to as “**Standard Chartered**”).
2. Standard Chartered credit cards eligible for CCHG2002SC-Promotion are Standard Chartered WorldMiles World Mastercard®, Standard Chartered Visa Platinum Card, and Standard Chartered JustOne Platinum Mastercard® (hereinafter referred to as “**Eligible Credit Cards**”).

Promotion Period

3. The CCHG2002SC -Promotion comprises of the following periods:
 - a. “**Sign-Up Period**” runs from 10 February 2020 to 11 February 2020, both dates inclusive; and
 - b. “**Redemption Period**” runs from 15 March 2020 to 30 June 2020, both dates inclusive.

Promotion Eligibility

4. The CCHG2002SC-Promotion is open to individuals who are:
 - a. 21 years old and above, with a residential address in Peninsular Malaysia; and
 - b. successfully registers interest for any of the Eligible Credit Cards via CompareHero.my website (<https://www.comparehero.my>) or Facebook (www.facebook.com/CompareHero.my) or Instagram (www.instagram.com/comparehero.my) during the Sign-Up Period; and
 - c. is either a New-to-Bank or New-to-Card applicant; and
 - i. New-to-Bank is defined as a person who does not have any accounts or a financial relationship with Standard Chartered.
 - ii. New-to-Card is defined as an existing bank customer who does not hold any active credit card/s from Standard Chartered in the past six (6) months.
 - d. have their application of the Eligible Credit Cards approved and activated (hereinafter referred to as “**Cardholder/s**”) within thirty (30) days from the end date of CCHG2002SC-Promotion.
5. The following individuals are not eligible for the CCHG2002SC-Promotion:
 - a. those who have registered under a different CompareHero.my promotion within three (3) months from the start date of CCHG2002SC-Promotion; and/or
 - b. existing Standard Chartered cardholders who cancel any of the Eligible Credit Cards within six (6) months from the date of approval of their Eligible Credit Cards’ application; and/or
 - c. existing Standard Chartered cardholders who are participating in any other concurrent Standard Chartered credit card promotions; and/or
 - d. holder(s) of invalid or cancelled Standard Chartered Eligible Credit Cards and/or whose accounts are delinquent within Standard Chartered’s definition at any time during the Sign-Up Period; and/or
 - e. holder(s) of a company and/or corporate Standard Chartered credit cards; and/or
 - f. those who make a direct or online application for any of Eligible Credit Cards at any Standard Chartered branch / Standard Chartered websites / Standard Chartered sales representatives / other third-party sales agents.
6. CompareHero.my reserves the right to reject information submitted on the CompareHero.my website and social media if we deem it not legible, in non-English alphabets, use of foul language, or suspected as spam.

Promotion Mechanics

7. Cardholders who fulfil Promotion Eligibility (clauses 4 and 5, and its subclauses) will be considered a “**Successful Cardholder**” of the CCHG2002SC-Promotion.
8. Each Successful Cardholder is entitled to only one (1) CCHG2002SC-Promotion gift (hereinafter referred to as “**Promotion Gift**”), regardless of the number of approved and activated Eligible Credit Cards from Standard Chartered.
 - a. Each Successful Cardholder has to **choose only ONE (1) of two available Promotion Gift(s)** when they sign up for a credit card.
 - b. Promotion Gift decision by Successful Cardholders is final and no further changes will be entertained.

- c. CompareHero reserves the right to change or replace the gift based on the available stock from the merchants. Refer to Clause 15.

Gift Redemption

10. For the avoidance of doubt, at the time of gift redemption, should a Successful Cardholder be unable to provide a residential address in Peninsular Malaysia or declines the said Promotion Gift, a “**Substitute Gift**” will be issued.
 - a. Substitute Gift is defined as an RM200 Lazada eVoucher and request for other options will not be entertained.
11. Promotion Gift or Substitute Gift cannot be transferred to other parties, is not refundable and not exchangeable for cash, credit, or other goods.
12. CompareHero.my will contact all Successful Cardholders between 4-8 weeks after card activation date (pending official Standard Chartered reports):
 - a. via email (email address in CompareHero.my’s record) with gift redemption instructions; and/or
 - b. via SMS (mobile phone number in CompareHero.my’s record) as a reminder to respond to the email above.
13. Promotion Gift or Substitute Gift is considered redeemed when a Successful Cardholder responds to the gift redemption email instructions before the end of the Redemption Period. Any attempt of gift redemption after the Redemption Period will not be entertained and no Promotion Gift will be issued.
