

## March 2020 Citibank Flash Deal Credit Cards Promotion Terms & Conditions

The 1st and subsequently every 4th successfully approved & activated Citi card from the March 2020 Citibank Flash Deal Credit Cards Promotion will take home a FREE PlayStation® PS4™ Slim 1TB. Limited to 60 units only.

1. The March 2020 Citibank Flash Deal Credit Cards Promotion (hereinafter referred to as “CCFD2003CT2-Promotion”) is organized by Compargo Malaysia Sdn Bhd (1050769-U) for CompareHero.my and in partnership with Citibank Berhad (297089-M) (hereinafter referred to as “Citibank” or “Citi”).
2. Citibank credit cards eligible for CCFD2003CT2-Promotion are Citi Rewards Mastercard, Citi PremierMiles Mastercard, Citi Clear Card, Citi Cash Back Platinum Card, and Lazada Citi Platinum Card (hereinafter referred to as “Eligible Credit Cards”).

### Promotion Period

3. The CCFD2003CT2-Promotion comprises of the following periods:
  - a. “Sign-Up Period” runs from 25 March 2020 to 27 March 2020, both dates inclusive;
  - b. “Standard Redemption Period” runs from 15 April 2020 to 31 July 2020, both dates inclusive; and
  - c. “Promotion Gift Redemption Period” runs from 15 June 2020 to 31 July 2020, both dates inclusive.

### Promotion Eligibility

4. The CCFD2003CT2-Promotion is open to individuals who are:
  - a. 21 years old and above, with a residential address in Peninsular Malaysia; and
  - b. successfully registers interest for any of the Eligible Credit Cards via CompareHero.my website (<https://www.comparehero.my>) or Facebook ([www.facebook.com/CompareHero.my](http://www.facebook.com/CompareHero.my)) or Instagram ([www.instagram.com/comparehero.my](http://www.instagram.com/comparehero.my)) during the Sign-Up Period; and
  - c. is either a New-to-Bank or New-to-Card applicant; and
    - i. New-to-Bank is defined as a person who does not have any accounts or a financial relationship with Citibank.
    - ii. New-to-Card is defined as an existing bank customer who does not hold any active credit card/s from Citibank.
  - d. have their application of the Eligible Credit Cards approved and activated (hereinafter referred to as “Cardholder/s”) within forty-five (45) days from the end date of CCFD2003CT2-Promotion.
5. The following individuals are not eligible for the CCFD2003CT2-Promotion:
  - a. those who have registered under a different CompareHero.my promotion within three (3) months from the start date of CCFD2003CT2-Promotion; and/or
  - b. existing Citibank cardholders who cancel any of the Eligible Credit Cards within twelve (12) months from the date of approval of their Eligible Credit Cards’ application; and/or
  - c. existing Citibank cardholders who are participating in any other concurrent Citibank credit card promotions; and/or
  - d. permanent and/or contract employees of Citibank (including its subsidiaries and related companies) and their respective immediate family members;
  - e. holder(s) of invalid or cancelled Citibank Eligible Credit Cards and/or whose accounts are delinquent within Citibank’s definition at any time during the Sign-Up Period; and/or
  - f. holder(s) of a company and/or corporate Citibank credit cards; and/or
  - g. any person who has committed or suspected of committing any misconduct, fraudulent or wrongful acts in relation to their card account/s, any facility, service or accommodation granted by Citibank, including Citibank Online (website); and/or
  - h. those who make a direct or online application for any of Eligible Credit Cards at any Citibank branch / Citibank websites / Citibank sales representatives / other third-party sales agents.
6. CompareHero.my reserves the right to reject information submitted on the CompareHero.my website and social media if we deem it not legible, in non-English alphabets, use of foul language, or suspected as spam.

## Promotion Mechanics

7. Cardholders who fulfil Promotion Eligibility (clauses 4 and 5, and its subclauses) will be considered “**Shortlisted Cardholders**” of the CCFD2003CT2-Promotion.
8. “**Shortlisted Cardholders**” of the CCFD2003CT2-Promotion, which are Approved & Activated will be sorted in a list by the application dates from earliest to latest to determine the 1st position & every 4th position(s), where these applicants will be defined as **1st Successful Cardholder** and every **4th Successful Cardholder(s)** respectively. This sorting is done by CompareHero.my, not the Bank.
  - a. APPROVED & ACTIVATED AND SORTED BY APPLICATION DATES IN THE APPROVAL LIST:  
*E.g. Applicant Number 1 (1st Successful Cardholder) will receive a Promotion Gift and a Standard Gift; Applicant Number 2 to 4 will receive a Standard Gift; Applicant Number 5 (every 4th Successful Cardholder) will receive the Promotion Gift and a Standard Gift; Applicant Number 6 to 8 will receive a Standard Gift, and Applicant Number 9 (every 4th Successful Cardholder) will receive the Promotion Gift and a Standard Gift; and so on.*
9. The 1st Successful Cardholder and every 4th Successful Cardholder(s) is eligible to only one (1) **Promotion Gift** & one (1) **Standard Gift**.
10. The **Promotion Gift** is defined as a single unit (1) PlayStation® PS4™ Slim 1TB. The Promotion Gift is limited to 60 units only.
11. The **Standard Gift** is defined as a single unit (1) of Barry Smith 20” Hard Case Luggage.
12. The **Promotion Gift** will be given out to one (1) 1st Successful Cardholder and to fifty-nine (59) of every 4th Successful Cardholder(s) OR until the list is exhausted.
13. Successful Cardholders who receive the Promotion Gift are not able to participate in other sign-up card campaigns, promotions or offers by Citibank or its third-party sales agents.
14. Once all 60 Promotion Gifts have been honoured, all remaining Successful Cardholders (which is not part of the one (1) 1st Successful Cardholder and fifty-nine (59) of every 4th Successful Cardholder(s)) will each receive a Standard Gift.
15. For the 60 Promotion Gifts, if in the event the Promotion Gifts runs out of stock, at the discretion of CompareHero.my, an alternative or goodwill gift of similar value maybe offered to the first 60 Successful Cardholders [which comprises of the one (1) 1st Successful Cardholder and fifty-nine (59) of every 4th Successful Cardholder(s)] OR until the list is exhausted, both in running sequence (*eg: once the Promotion Gifts runs out of stock, the next and subsequent Successful Cardholders which is part of the 60 Successful Cardholders will get an alternative or goodwill gift of similar value and not the Promotion Gift*).

## Gift Redemption

16. For the avoidance of doubt, it is the Successful Cardholder’s responsibility to redeem the Promotion Gift within the Redemption Period.
17. CompareHero.my will contact all Successful Cardholders in June 2020 to redeem the Promotion Gift after card activation (pending official bank reports):
  - a. via email (email address in CompareHero.my’s record) with gift redemption instructions; and/or
  - b. via SMS (mobile phone number in CompareHero.my’s record).
18. At the time of gift redemption, should a Successful Cardholder be unable to provide a residential address in Peninsular Malaysia, a “**Substitute Gift**” will be issued.
  - a. Substitute Gift is defined as a RM100 Lazada eVoucher and request for other options will not be entertained.
19. Promotion Gift, Standard Gift, or Substitute Gift cannot be transferred to other parties, is not refundable and not exchangeable for cash, credit, or other goods.
20. Promotion Gift, Standard Gift, or Substitute Gift is considered redeemed when a Successful Cardholder responds to the gift redemption email instructions before the end of the Redemption Period. Any attempt of gift redemption after the Redemption Period will not be entertained and no Promotion Gift will be issued.
21. Delivery or fulfilment of Promotion Gift is estimated to be between 2-4 weeks from redeemed date (pending stock availability, and/or merchant delivery schedules).
22. Promotion Gift, Standard Gift, or Substitute Gift choice of size, technical specifications and/or colour is at the discretion of CompareHero.my, based on available stock from the merchant/s. CompareHero.my can replace the

Promotion Gift, Standard Gift, or Substitute Gift with something of equivalent or higher value if the merchant/s runs out of stock.

23. Promotion Gift, Standard Gift, or Substitute Gift does not include any accessories or items (unless stated) that may be shown on any marketing materials, as they are for illustration purposes only.
24. The use of the Promotion Gift is subject to terms and conditions of the issuing merchant/s. All additional terms and conditions will be stated in full, upon delivery or fulfilment of Promotion Gift. Additional terms and conditions may include validity dates, spend requirements, applicable or exclusion products and other conditions. The issuing merchant/s reserves the right to alter, cancel, terminate or suspend the order or any part thereof or any part of the applicable terms and conditions from time to time, with or without any prior notice.
25. All servicing or warranty claims should be directed to the merchant, manufacturer or distributor of the Promotion Gift, Standard Gift, or Substitute Gift. Please refer to the warranty card / box / notification attached with the Promotion Gift.

Once the gift (Promotion Gift, Standard Gift, or Substitute Gift) has been successfully redeemed and received, it must be checked for any defects, and any defects must be reported to the vendor within 3 working days from the date of receive, or else any complaints or any matters arising from the defects will not be entertained.
27. CompareHero.my and the participating banks are not in any way endorsing, sanctioning, approving or supporting the brand/s or merchandise of the Promotion Gift. Any query and/or dispute on the usage of the Promotion Gift must be directed to, and resolved directly with the issuing merchant/s.
