

May 2020 Standard Chartered Credit Cards Hero Giveaway Promotion Terms & Conditions

1. The Standard Chartered Credit Card Hero Giveaway Promotion (hereinafter referred to as “CCHG2005SC-Promotion”) is organized by Compargo Malaysia Sdn Bhd (1050769-U) for CompareHero.my and in partnership with Standard Chartered Bank Malaysia Berhad (115793-P) (hereinafter referred to as “Standard Chartered”).
2. Standard Chartered credit cards eligible for CCHG2005SC-Promotion are Standard Chartered WorldMiles World Mastercard®, Standard Chartered Visa Platinum Card, Standard Chartered Liverpool FC Cash Back Card, and Standard Chartered JustOne Platinum Mastercard® (hereinafter referred to as “Eligible Credit Cards”).

Promotion Period

3. The CCHG2005SC-Promotion comprises of the following periods:
 - a. “Sign-Up Period” runs from 4 May 2020 to 6 May 2020, both dates inclusive;
 - b. “Redemption Period” runs from 13 June 2020 to 31 August 2020, both dates inclusive;

Promotion Eligibility

4. The CCHG2005SC-Promotion is open to individuals who are:
 - a. 21 years old and above;
 - b. Having a residential address in Peninsular Malaysia; and
 - c. successfully registers interest for any of the Eligible Credit Cards via CompareHero.my website (<https://www.comparehero.my>) or Facebook (www.facebook.com/CompareHero.my) or Instagram (www.instagram.com/comparehero.my) during the Sign-Up Period; and
 - d. is either a New-to-Bank or New-to-Card applicant; and
 - i. New-to-Bank is defined as a person who does not have any accounts or a financial relationship with Standard Chartered.
 - ii. New-to-Card is defined as an existing bank customer who does not hold any active credit card/s from Standard Chartered in the past six (6) months.
 - e. have their application of the Eligible Credit Cards approved and activated (hereinafter referred to as “Cardholder/s”) within thirty (30) days from the end date of CCHG2005SC-Promotion.
5. The following individuals are not eligible for the CCHG2005SC-Promotion:
 - a. those who have registered under a different CompareHero.my promotion within three (3) months from the start date of CCHG2005SC-Promotion; and/or
 - b. existing Standard Chartered cardholders who cancel any of the Eligible Credit Cards within six (6) months from the date of approval of their Eligible Credit Cards’ application; and/or
 - c. existing Standard Chartered cardholders who are participating in any other concurrent Standard Chartered credit card promotions; and/or
 - d. holder(s) of invalid or cancelled Standard Chartered Eligible Credit Cards and/or whose accounts are delinquent within Standard Chartered’s definition at any time during the Sign-Up Period; and/or
 - e. holder(s) of a company and/or corporate Standard Chartered credit cards; and/or
 - f. those who make a direct or online application for any of Eligible Credit Cards at any Standard Chartered branch / Standard Chartered websites / Standard Chartered sales representatives / other third-party sales agents.
6. CompareHero.my reserves the right to reject information submitted on the CompareHero.my website and social media if we deem it not legible, in non-English alphabets, use of foul language, or suspected as spam.

Promotion Mechanics

7. Cardholders who fulfil Promotion Eligibility (clauses 4 and 5, and its subclauses) will be considered a “Successful Cardholder” of the CCHG2005SC-Promotion.
8. Each Successful Cardholder is entitled to only one (1) CCHG2005SC-Promotion gift (hereinafter referred to as “Promotion Gift”), regardless of the number of approved and activated Eligible Credit Cards from Standard Chartered.
 - a. Each Successful Cardholder has to **choose only ONE (1) of two available Promotion Gift(s)** when they sign up for a credit card.

- b. Promotion Gift decision by Successful Cardholders is final and no further changes will be entertained.
 - c. CompareHero reserves the right to change or replace the gift based on the available stock from the merchants. Refer to Clause 15.
9. Promotion Gift is defined as either one (1) AFTERSHOKZ Titanium Headphones OR one (1) BLACK and DECKER Steam Mop Steam Cleaner Home Cleaner.
10. Successful Cardholders without a residential address in Peninsular Malaysia will be issued a “**Substitute Gift**” instead.
- a. Substitute Gift is defined as a **RM200 Lazada eVoucher** and request for other options will not be entertained.

Gift Redemption

11. For the avoidance of doubt, it is the Successful Cardholder’s responsibility to redeem the Promotion Gift or Substitute within their respective Redemption Periods.
12. CompareHero.my will contact all Successful Cardholders to redeem the Promotion Gift or Substitute Gift, between 4-8 weeks after card activation (pending official Standard Chartered reports):
 - a. via email (email address in CompareHero.my’s record) with gift redemption instructions; and/or
 - b. via SMS (mobile phone number in CompareHero.my’s record).
13. The Promotion Gift or Substitute Gift cannot be transferred to other parties, is not refundable and not exchangeable for cash, credit, or other goods.
14. The Promotion Gift or Substitute Gift is considered redeemed when a Successful Cardholder responds to the gift redemption email instructions before the end of the Redemption Period. Any attempt of gift redemption after the Redemption Period will not be entertained and no Promotion Gift will be issued.
15. Delivery or fulfilment of Promotion Gift or Substitute Gift is estimated to be 4 weeks from redeemed date (pending stock availability, and/or merchant delivery schedules).
16. The Promotion Gift or Substitute Gift choice of size, technical specifications and/or colour is at the discretion of CompareHero.my, based on available stock from the merchant/s. CompareHero.my can replace the Promotion Gift or Substitute Gift with something of equivalent or higher value if the merchant/s runs out of stock.
